## NOTICE OF INTENT TO ADOPT A NEGATIVE DECLARATION PURSUANT TO THE CALIFORNIA ENVIRONMENTAL QUALITY ACT

In compliance with Section 15072 of the California Environmental Quality Act Guidelines, notification is hereby given to responsible agencies, trustee agencies, interest groups and the general public that the Bureau of Electronic and Appliance Repair, Home Furnishings, and Thermal Insulation (BEARHFTI) has prepared an Initial Study/Negative Declaration (IS/ND), which evaluates potential environmental impacts of a proposed regulatory change to Title 4 of the California Code of Regulations, sections 1374 and 1374.3 regarding flammability standards.

Pursuant to Title 14 of the California Code of Regulations, Section 15105, the IS/ND will undergo a 30-day public review period.
